Martin Luther King, Jr. Internship Program Update

This year marks the 25th anniversary of our successful summer internship program. The program, which is designed to promote and support minority attorneys' work in the Pennsylvania Legal Aid Network (PLAN) programs across the Commonwealth, has hosted a total of 352 law students to date. The goal of the program is to initiate future attorneys to the lifelong commitment of providing access to justice for all individuals regardless of their ability to pay. Ten paid internships are awarded each summer to law students who participate in legal services work over a 10 week period. This year, PLAN hosted 11 interns. A one day poverty law training is provided at the beginning of the internship. At the end of the program, interns are also asked to complete an essay sharing their summer experiences which are compiled into a booklet called the MLK Intern Drum Major Essay Collection. 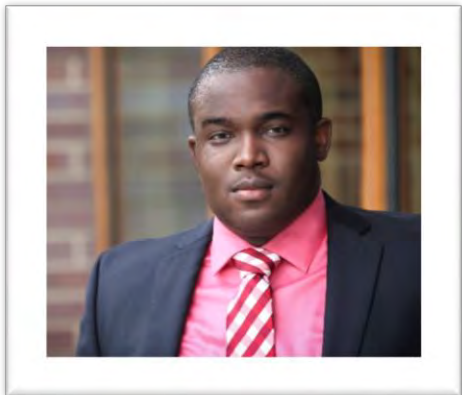

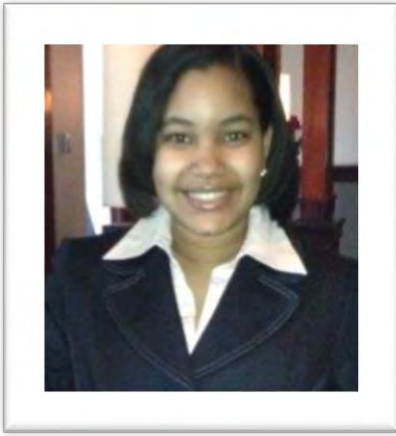
About Kadeem

Current Martin Luther King, Jr. Fellows Continue to Shine

In November 2016, we hired **Addie Brice**, a member of the MLK Intern Class of 2016. Addie received her J.D. in May 2016 from Widener University Delaware Law School and graduated with a BA from Temple University, Fox Business School. An employee of Northwestern Legal Services, Addie handles various types of cases including domestic violence, unemployment compensation, landlord/tenant, and social security. However, her primary area of practice is family law, specifically custody disputes. Since starting, Addie has participated in numerous Pennsylvania Legal Aid Network training events and most recently joined the PLAN, Inc. Statewide Conference Planning Committee which is designed to guide PLAN, Inc. in the development of our annual statewide conference.





In our previous newsletter, we introduced you to **Morgan (Jenkins) Moody**. Morgan began her fellowship at Neighborhood Legal Services Association (NLSA) in November 2015. Morgan's initial work focused on veterans matters including housing and benefits, community outreach, and referrals. However, Morgan now heads NLSA's new domestic violence prevention project. The goal of the project is to establish a system in Allegheny County to reduce the domestic violence victims who do not complete the Protection From Abuse (PFA) process. Situated in an office at the county courthouse, Morgan, speaks to domestic violence victims "before" they attempt to file for a temporary PFA order. Like Addie, Morgan is also very involved in the PLAN community and is a member of the PLAN, Inc. Statewide Conference Planning Committee.

Fellowship Program Success

We are extremely pleased with the success of the MLK Fellowship Program. Since its inception in 2004, 20 lawyers have been placed as fellows with PLAN legal aid programs and scores of other former interns have entered other public interest careers. The program is an integral part of PLAN, Inc.'s goal to initiate new lawyers into public interest law careers. PLAN, Inc. partners with a sponsoring regional or specialty legal services program and pays 50% of the fellow's salary, benefits, and student loan assistance up to \$5500 each per year of the two year fellowship. Salary is commensurate with that of the sponsoring program.

While a few Fellows have moved on from employment at PLAN programs to other public interest or governmental organizations, during fiscal year 2016-17, five former MLK Fellows or Interns remained employed at PLAN programs.

In the past fiscal year, PLAN programs handled about 65,000 client cases; saving their homes from foreclosure, protecting them from domestic violence, securing health insurance, establishing custody stability for children, and helping clients in many other ways.

The Fellowship Program has a proven track record of launching minority law students into careers as public interest lawyers and legal aid attorneys and has generated a reliable recruitment pool for legal aid organizations. PLAN, Inc. appreciates the financial support it receives from Pennsylvania law firms, businesses, and individuals to help support this program. PLAN, Inc. does not realize any of these sponsorship funds, but funnels them directly to the salary and benefits of our fellows. Our goal is to place at least 2 fellows per fiscal year.
