Program opens November 1, 2019 // Program closes April 10, 2020

Cash Grants

Amount of Benefit:

\$200 (minimum grant) - \$1000 (maximum grant) to help eligible low income household pay the cost of home heating.

General Eligibility Requirements:

- Income at or below 150% of the Federal Poverty Level (see chart on back page)
- Responsible for the main source of heat in the household (pay utility or fuel vendor directly; or indirectly through rent)
- Residency in Pennsylvania

Crisis Grants

Amount of Benefit:

Up to \$600 to stop a shut-off of utility service, to get service turned back on, or to get fuel if out of fuel or about to run out of fuel.

General Eligibility Requirements:

- Income at or below 150% of the Federal Poverty Level (see chart on back page)
- Responsible for the main source of heat in the household (pay utility or fuel vendor directly; or indirectly through rent)
- Residency in Pennsylvania
- Actual or imminent home heating emergency that can be resolved by crisis funds

Crisis Interface Program

Benefits:

This program connects low income households with weatherization providers that may:

- Repair heating system
- Loan auxiliary heater
- Repair gas or other fuel lines
- Replace un-repairable heating systems
- Repair hot water heating system
- Heating system pipe thawing service
- Repair broken windows
- Provide blankets

General Eligibility Requirements:

- Income at or below 200% of the Federal Poverty Level
- Responsible for the main source of heat in the household
 - o pay utility or fuel vendor directly; or pay indirectly through rent
- Residency in Pennsylvania
- Client education on the care and maintenance of their heating system
- Program benefits are available to tenants; however, landlord permission may be required

Changes and Updates to LIHEAP in 2019-2020

- **No Supplemental Cash Grants:** Turn On and Supplemental Grants for vulnerable households will not be available this year.
- Preseason Applications and Compass Postcards: Preseason applications and COMPASS
 Postcards will be mailed out to all households who received LIHEAP last year. Mailing began on
 September 23, 2019. Households that receive a postcard can apply through COMPASS as soon
 as mailing is received and cash grants will be issued early, any time after October 1, 2019.
- Cash grant formula: There was a change in the formula, which may increase grants by \$15-\$20.
- Late Fees: DHS has clarified that LIHEAP grants can be used to pay late fees.
- **Earned income from temporary census employment** is <u>excluded</u> for purposes of household eligibility and benefit calculation.
