

Dear Client:

We are writing to let you know that if you will be <u>APPLYING</u> for a green card or visa there are new federal rules that may apply to you. You may have heard about these new rules, which are called the "public charge" rules. These rules are scheduled to go into effect on October 15, 2019.

These rules will not change your benefits. These rules do change who may be able to get a green card. There are many exceptions to these rules. **Many immigrants who are eligible for public benefits can still safely get benefits under the new public charge rules.**

THE PUBLIC CHARGE RULES DO NOT APPLY TO YOU IF:*

- You already have a green card and remain in the U.S.
- You are renewing your green card.
- You are applying for U.S. citizenship.
- You have refugee or asylum status.

UNDER THE NEW PUBLIC CHARGE RULES:

- You may still get Medical Assistance without risk of being found a public charge if you are under the age of 21, pregnant or had a baby within the last 60 days, or need emergency medical assistance.
- Your green card or visa application cannot be denied because your children or other family members get public benefits.
