CELEBRATING 30 YEARS!

It is truly remarkable to be celebrating the 30th anniversary of PLAN's Martin Luther King, Jr. (MLK, Jr.) Summer Internship Program. The program was conceived at a time when today's discussions of racial equity and justice were – as Dr. King might put it – merely a "dream." The program was created through the efforts of five Black women: Edie Benson, Carolyn Johnson, Debi Johnson, Linda Renick, and Phyllis Stevens. Fondly known as the "Founding Mothers," these women recognized the need to create a PLAN diversity pipeline. They felt it was important for PLAN attorneys to be more representative of the client population they serve, a majority diverse population. These women worked alongside members of the PLAN and client community, including Mrs. Louise Brookins, to convince funders to provide funding to support the MLK, Jr. Summer Internship Program. Since the program's inception in 1991, 402 law students have participated in the program.

In 2003, an evaluation of the MLK, Jr. Summer Internship Program revealed that while the program was successful, its full potential had yet to be realized. In response, PLAN created the MLK, Jr. Fellowship Program in 2004. To date, PLAN has hired a total of 29 MLK, Jr. Fellows, 12 of whom remain employed by PLAN. While the others may have moved on from the PLAN network, many remain committed to public interest work. In PLAN's ongoing commitment to the success of its MLK, Jr. Programming and expansion of its diversity efforts throughout the network, PLAN, Inc. recently announced Arlene Marshall-Hockensmith, Esquire as PLAN's first Director of Diversity, Equity, Including, and Belonging (DEIB). Arlene, a former MLK, Jr. Intern, Class of 2005, is the first woman of color to hold a senior leadership role at PLAN, Inc. Shortly thereafter, the PLAN Board of Directors appointed Jayme Cassidy, Esquire, also a woman of color, as the next Executive Director of PLAN, Inc.

As PLAN Director of DEIB, Arlene will continue to oversee the MLK, Jr. Programming and support PLAN Affinity Groups while concentrating on supporting PLAN, Inc. and PLAN network programs in developing a vision and strategy around incorporating DEIB in all parts of the network's culture and operations, including hiring, retention, supervision, data collection and analysis, advocacy, and communication. Another important part of her role will be to assist PLAN, Inc. and PLAN programs in assessing their current DEIB status and implementing inclusiveness processes that aim to increase and sustain diversity among PLAN staff at all levels.

As you can see, PLAN has come a long way over the past 30 years. We are pleased with our diversity efforts, but work remains to be done. The continued success of our MLK, Jr. Programs depends not only on those within the PLAN network, but our community partners, funders, donors, and you, our readers. The fondest memory of my internship experience was developing friendships with the lawyers and paralegals in the program like Michael Goldberg, Jim Kearney, Paul Sternberg, Geisha Cruz, Susan Danforth.

During my time as an MLK, Jr. Intern, I learned that advocacy was what I was meant to do. Previously, I thought I wanted to work in public policy development to make big changes for poor people and victims of discrimination and abuse. After I started at Central Pennsylvania Legal Services (now known as PLAN), I knew within a week that my calling was to work as an advocate.

This internship program is why I understand the value of pro bono work. It is why I understand the value of legal services work. I understand the struggles of poor people, that it is more likely systemic than personal. That understanding helps me to have more understanding to advocate for change on the political level with other organizations and lawyers.

My message for future MLK, Jr. Interns is to listen to your clients tell their stories of their lives. It is easy to say we would not make the same choices if we were in that position, but the choices are limited and challenging. Poor people do not get many breaks and ironically people with means get more forgiveness and opportunities than poor people. Consider what you can do to change the system that keeps them locked in their situation and form alliances with public interest advocates to make changes.

The MLK, Jr. Internship Program was intended to better reflect the look of attorneys in legal aid programs, as compared to the range of clients represented by these attorneys. I am convinced that without this program, PLAN programs would have not been as successful at hiring the diverse staff that they have now. During my involvement with the program, my fondest memory goes back 30 years, to hiring PLAN's first intern, Sharon López. Witnessing her great successes and commitment to public interest over the years, including being elected as President of the Pennsylvania Bar Association, has been very impactful.



The program overall has been a great success, resulting in many interns and fellows being hired, with many of them staying on for careers in public interest law. But there is still more to do. Today's world offers a highly competitive market and legal aid programs need to continue to look to ways of diversifying staff. I'm proud to have been part of the internship from its inception and while Executive Director of PLAN, to have been part of the oversight and success of the program, including the decision 20 years ago to expand from a summer internship program to also include the fellowship program, placing attorneys at PLAN programs.

MARTIN LUTHER KING, JR. SUMMER INTERNSHIP PROGRAM

This year marks the 30th anniversary of our successful MLK, Jr. Summer Internship Program. Initiated in 1991 by the Pennsylvania Legal Services Black Caucus, this program is designed to promote and support minority attorneys' work in the Pennsylvania Legal Aid Network programs across the Commonwealth. To date, PLAN has hosted a total of 402 law students.

The goal of our internship program is to instill in future attorneys a lifelong commitment of providing access to justice for all individuals, regardless of their ability to pay, and to promote diversity within PLAN's programs. Ten paid internships are awarded each summer to law students who participate in legal services work over a 10-week period. Our interns engage in a variety of situations through which they can better understand the special legal issues faced by those who live in poverty and low-income communities. In turn, they provide valuable services to PLAN clients.

This summer, PLAN welcomed 10 new interns into our network. Our interns worked both in-person and remotely for PLAN programs across the Commonwealth for a 10-week period. After a two-year hiatus from in-person trainings, PLAN, Inc. hosted a two-day in-person poverty law orientation for MLK, Jr. Interns at its Harrisburg office. IOLTA Fellows and an Equal Justice Works Fellow also joined. The training was well received, and everyone very much appreciated returning to in-person training.

At the conclusion of each internship program cycle, our interns are required to complete an essay sharing their summer experiences, which is compiled into a booklet called the MLK, Jr. Summer Internship Program Drum Major Essay Collection. MARTIN LUTHER KING, JR. FELLOWSHIP PROGRAM

This year marks the 17th anniversary of our MLK, Jr. Fellowship Program. In 2003, an evaluation of the MLK, Jr. Summer Internship Program revealed that while the internship experience had been a very positive one for PLAN, Inc. law students, clients, and programs, the goal to enhance cultural and ethnic diversity within PLAN programs was not fully realized. In response, PLAN, Inc. created the MLK, Jr. Fellowship Program.

In partnership with a sponsoring PLAN regional or specialty program, law school graduates and new-to-practice attorneys are hired for two-year fellowships. Our Fellowship Program is intended to support and promote new lawyers who are interested in long-term public interest careers. MLK, Jr. Fellows are assigned mentors and supervised by experienced attorneys. Salary and benefits are determined by the host program. In addition, MLK, Jr. Fellows are eligible for up to \$11,000 of loan repayment assistance during the two-year fellowship period.

MARTIN LUTHER KING, JR. FELLOWS CONTINUE TO SHINE

Amy Chin-Arroyo, Esq.



Amy, former MLK, Jr. Intern, Class of 2019, received her JD in May 2021 from Temple University Beasley School of Law and graduated with a B.A. in English and Spanish, International Studies
Concentration from Williams College. Her work at Justice at Work involves providing high quality direct legal assistance, community education, and advocacy on behalf of eligible clients with a focus on handling cases involving employment-related issues, immigration matters, landlord-tenant matters, and consumer protection matters.

Arlene Marshall-Hockensmith: Amy, you now have one year of experience as a practicing attorney. Please share with our readers your most memorable case to date.

Amy Chin-Arroyo: I recently submitted a T visa application (a visa application for victims of severe trafficking) for a client who experienced labor trafficking and sexual harassment at the hands of a repeat trafficker in the agricultural industry in Pennsylvania. This client's resilience in overcoming the trauma of the trafficking she experienced while also raising her young son was very inspiring to me.

Arlene Marshall-Hockensmith: What impact do you believe the MLK, Jr. Fellowship Program has made on you? PLAN?

Amy Chin-Arroyo: The fellowship program has been a wonderful source of support to me thus far as a new attorney at Justice at Work. The funding and loan repayment assistance program has made it financially feasible for me to pursue a career in public interest law. As the first attorney in my family and one of relatively few Asians working in public interest law, it has been lovely and inspiring to meet and learn from other BIPOC attorneys who are participating in the fellowship, as well as through PLAN's Asian Pacific American Affinity Group. I feel very fortunate to have access to such a diverse and supportive professional network.

Arlene Marshall-Hockensmith: What message do you have for PLAN and supporters of the MLK, Jr. Fellowship Program?

Amy Chin-Arroyo: Thank you for continuing to fund and support PLAN and the MLK, Jr. Programs. Without the MLK, Jr. Internship Program, I would not have done my 2L internship at Justice at Work which led to my current job. The internship program gave me a fantastic introduction to the public interest legal community in Pennsylvania and a chance to meet and learn from peers and public interest attorneys from across the state. Continuing to provide this type of mentorship, funding, and support to diverse law students is essential to diversifying the profession.

Richardo Brown-Whitt, Esq.

Richardo received his JD in May 2021 from Wake Forest University School of Law and graduated with a B.A. in Political Science and English Writing from the University of Pittsburgh.



His work at the Pennsylvania Institutional Law Project involves litigating cases on behalf of incarcerated and institutionalized individuals, primarily in federal court, on statutory and constitutional civil rights claims. He conducts visits to prisons and institutions to meet with clients and monitor the ongoing conditions of confinement. He also works closely with the PILP legal team and clients to investigate and develop potential cases and develop relationships with community partners.

Arlene Marshall-Hockensmith: Richardo, you now have one year of experience as a practicing attorney. Please share with our readers your most memorable case to date.

Richardo Brown-Whitt: One of the first cases that I worked on was Remlinger v. Leb. Cnty, a case involving the shackling of a pregnant woman during labor. This case is ongoing, however it immediately grounded me in the seriousness of the work handled by the Pennsylvania Institutional Law Project.

Arlene Marshall-Hockensmith: What are your thoughts on your fellowship experience thus far?

Richardo Brown-Whitt: I thoroughly enjoy being an advocate for my clients. Many of our clients face significant hurdles with initiating and maintaining lawsuits. I am honored to work closely with clients who inspire me through their bravery and willingness to come forward and tell their stories.

Arlene Marshall-Hockensmith: What message do you have for PLAN and supporters of the MLK, Jr. Fellowship Program?

Richardo Brown-Whitt: PLAN has many programs within its network, many of which were unknown to me before applying to this fellowship program. The MLK, Jr. Fellowship Program doesn't just increase the diversity within a particular host program, but it also increases the visibility of all the other PLAN programs.

Devyne Byrd, Esq.



Devyne received her JD in May 2019 from the University of Virginia School of Law and graduated with a B.A. in History from Houston Baptist University. Her work at Legal Aid of Southeastern Pennsylvania involves representing clients facing issues regarding public benefits, consumer law and bankruptcy, employment, expungements, housing, family law, protection from domestic violence, and other cases as assigned.

Arlene Marshall-Hockensmith: Devyne, you now have one year of experience as a practicing attorney. Please share with our readers your most memorable case to date.

Devyne Byrd: My most memorable case thus far was a custody case where I procured full physical and legal custody for a mother who had not seen her child in over six months due to the other parent refusing to abide by the unofficial custody agreement they had negotiated. After two hearings, the mother was granted full custody and was reunited with her child. This case was memorable to me because it illustrated the slow moving, often traumatic process of family court. The child was with a parent that had not been actively parenting for over ten years but because there was no official custody agreement, there was no recourse except a hearing that took over six months to schedule.

Arlene Marshall-Hockensmith: What are your thoughts on your fellowship experience thus far?

Devyne Byrd: The fellowship has allowed me to learn several different types of law and explore my career under the mentorship of Black women which has been invaluable. I am grateful for the opportunity to hear their guidance and have so many amazing people invested in me.

Arlene Marshall-Hockensmith: What message do you have for PLAN and supporters of the MLK, Jr. Fellowship Program?

Devyne Byrd: This fellowship is important because it allows the community of lawyers to better reflect the communities we serve, bringing comfort to our clients as well as culturally informed representation and perspectives to our work.



Dominique Wiggins, Esq.

Dominique received her JD in May 2021 from Duquesne University School of Law and graduated with a B.A. in Psychology and Spanish from Rider University. Her work at Community Legal Services involves representing clients in both public housing and private landlord-tenant matters.

Arlene Marshall-Hockensmith: Dominique, you now have one year of experience as a practicing attorney. Please share with our readers your most memorable case to date.

Dominique Wiggins: My most memorable case happened during a Lawyer of the Day Shift while under my supervising attorney Kadeem Morris, a former MLK, Jr. Fellow. We reached an agreement with the landlord and landlord's attorney to re-house our client after a lockout. We provided assistance through a rental assistance agency and got our client re-housed in a week. Our client was very happy to return to his home after being locked out.

Arlene Marshall-Hockensmith: What are your thoughts on your fellowship experience thus far?

Dominique Wiggins: My fellowship experience has been amazing. I was very fortunate to be placed at Community Legal Services in the Housing Unit. Before starting this fellowship, I did not have a specific area law practice in mind. Since working in CLS's Housing Unit, I have found myself joining and co-leading policy efforts to improve the use of housing records for tenants seeking new housing with prior eviction filings.

Arlene Marshall-Hockensmith: What impact do you believe the MLK, Jr. Fellowship Program has made on you?

Dominique Wiggins: This program expanded the way I see public interest work. Initially, my view was very narrowly focused on specific areas of practice. I have also been impacted by the responses from clients who are able to identify with me culturally. Having clients respond positively to having me as their legal representation is a positive addition to the oftenstressful work that I do.

FELLOWSHIP PROGRAM SUCCESS

We are extremely pleased with the success of the Martin Luther King, Jr. Fellowship Program. Since its inception in 2004, 29 lawyers have been placed as fellows with PLAN legal aid programs and scores of other former interns have entered other public interest careers. The Fellowship Program is an integral part of PLAN, Inc.'s goal to initiate new lawyers into public interest law careers. PLAN, Inc. partners with a sponsoring regional or specialty legal services program and pays 50% of the Fellow's salary, benefits, and student loan assistance up to \$5,500 each per year of the two-year fellowship. Salary is commensurate with that of the sponsoring program.

In the past fiscal year, PLAN programs handled over 72,130 client cases, saving their homes from foreclosure, protecting them from domestic violence, securing health insurance, establishing custody stability for children, and helping clients in many other ways.

The Fellowship Program has a proven track record of launching minority law students into careers as public interest lawyers and legal aid attorneys and has generated a reliable recruitment pool for legal aid organizations. PLAN, Inc. appreciates the financial support and sponsorships it receives from Pennsylvania law firms, businesses, and individuals to help support this program. PLAN, Inc. does not realize any of these sponsorship funds, but funnels them directly to the salary and benefits of our fellows. 
